ENTRIES – On the form below to the secretary of the meeting by **Friday 29th October**. Entry Fee is £12.00 (Adults); £10.00 (Youth). Club Subs are £3 (Adult / Youth) through to end of 2010.

AWARDS – on final result of series, best three performances to count: An award to the best performance in each class (subject to a minimum of ten entries per class over the series). First Class awards will be given for larger numbers. Classes: Expert; Clubman-Expert; Clubman; Youth Expert; Over 40; Novice (C); Youth A/B, Youth C/D and Over-50. Gradings stand as of date of the first event in the series. Points will be awarded relevant to position: 10 for first, down to one for tenth position. Any uncompleted sections will be marked as 5 marks lost.
