ENTRIES -to the secretary of the meeting complete by **Friday 28th December**. Entry Fee £12.00 (Adults); £10.00 (Youth). Entries received after 26/10 Adult £15 ,Youth £12. Club Subs are £5 (Adult) / £3 (Youth) to end of 2013.

AWARDS - on final result of series, best three performances to count: An award to the best performance in each class (subject to a minimum of ten entries per class over the series). First Class awards will be given for larger numbers. Classes: Expert (A); Clubman-Expert (AB); Clubman (B); Novice (C); Over 40; Youth Expert and Youth A/B/C/D. Gradings stand as of date of the first event in the series. Points will be awarded relevant to position: 10 for first, down to one for tenth position. Any uncompleted sections will be marked as 5 marks lost.
